Program	Community Alternative Sentencing Center (CASC)
Location	1615 Harrison Ave Cincinnati OH 45214
Program Description	CASC offers programming to men and women who have received a felony or misdemeanor OVI/DUS with a mandatory minimum sentence of 6 to 90 days. CASC also provides programming to men and women with misdemeanor offenses, stepping down from Jail Based Services or ADAPT Residential to support their adjustments to community supervision.
Target Population	Misdemeanor and Felony OVI/DUS, Sep down from Jail Based Treatment or Halfway Houses.
Services Offered	Screening, Assessment, Treatment Planning, Group Sessions, Individual Sessions, Urine Drug Screening, Employment Services, Mental Health Treatment, Medication Assisted Treatment, Approved Movement for Work and Appointments, and Discharging Planning
Curriculum	University of Cincinnati Corrections Institute Cognitive Behavioral Interventions: Core Adult, Employment, and Substance Use Adult
Number of Beds	34 Men, 11 Women
Admission Criteria	Convicted of a felony or misdemeanor OVI/DUS or related OVI or DUS ordinance, on supervision with the Hamilton County Probation Department, received services at Jail Based Treatment or ADAPT Residential.

Program	Driver Intervention Program (DIP)
Location	Hyatt Place Cincinnati/Sharonville 11345 Chester Rd Cincinnati OH 45246
Program Description	DIP is certified by OMHAS to provide hotel based, jail alternative services to first time male and female OVI offenders and designed to reduce the likelihood of repeated OVI behavior. DIP is facilitated on the weekends, Thursday evening through Sunday. Cost to clients: \$375 for semi-private room, \$570 for private room. 50% of deposit is required at the time of registration, 100% due the Friday before the program starts.
Target Population	First Time OVI Offenders
Services Offered	Assessment, Alcohol and Drug Education, Traffic Safety, Referrals. Bilingual counselors and materials are available.
Curriculum	Safety Center Incorporated
Number of Beds	N/A
Admission Criteria	OVI offense, Reckless Operation where alcohol and/or drugs are involved.

Program	Jail Based Treatment
Location	1617 Reading Rd Cincinnati OH 45202
Program Description	Jail Based Treatment is a secured, residential, jail facility that is operated in partnership with the Hamilton County Sheriff's Department. Jail Based Treatment provides substance use disorder treatment services to individuals incarcerated in the Hamilton County Justice Center and offers four treatment tracks based on sentence and treatment recommendations: Short Term Program: 30-45 days focused on stabilization, discharge planning, and community referrals. Standard Program: 60-90 days focused on completion of full curriculum, discharge planning, and community referrals. Long Term Program: 120-180 days focused on completion of full curriculum with additional treatment, aimed to serve individuals who have been unsuccessful in less restrictive treatment options in the community.
Target Population	Men and Women incarcerated in the Hamilton County Justice Center with a substance use disorder diagnosis
Services Offered	Screening, Assessment, Treatment Planning, Group Sessions, Individual Sessions, Urine Drug Screening, Employment Services, Mental Health Treatment, Medication Assisted Treatment, Family Counseling, Peer Recovery Coaching, Parenting Education, Anger Management, Trauma and Grief Therapy, and Discharge Planning. The RSAT grant funds the peer recovery coaches, who provide aftercare assistance to discharged clients for up to a year post-discharge. The Criminal Justice Behavioral Health grant funds MAT services while clients are in the 1617 program and treatment and MAT services for discharged clients for up to 10 weeks post-discharge.

Admission Criteria	Meets Hamilton County Sheriff's Department security classification and alcohol and drug related charges/diagnosis
To make a referral	Impose full sentence, on Judge's sheet select the desired track, indicate "No 2 for 1 or 3 for 1," upon completion of the program Pre-Trial service will schedule mitigation, recommendation upon mitigation is to suspend the balance of days and place a period of one year of Community Control with an order to "Abide by Continuing Care Plan"; current incarcerated clients can request voluntary placement into the program
